Summer Updates and Celebrations: A Message From the GM!

June 1st is the start of our new fiscal year and it is the time of year to hear the laughter of children and sounds of people having fun at the swim lagoon! This really is a special amenity that sets Desert Shores apart from other communities in Las Vegas!

Mark your Calendars! June 25, 2023, is National Catfish Day! For one day only from 9:00am to 1:00pm, in Lake Lindsey only, Desert Shores registered residents and their guests may catch and keep catfish! Normally, the only fishing in the lakes is catch and release. However, during the fall fish count, the Nevada Department of Wildlife informed us that we have an abundance of catfish in Lake Lindsey and they recommended that we then out the catfish population in an effort to bolster the other fish populations. The Lakes Committee volunteers will be at both ends of Lake Lindsey to assist. Please take pictures of your catfish fry and share with the DSCA office at ecc@mydesertshores.com. Did you know that September 11th is Patriot Day? On September 10th, Desert Shores is holding a Patriot Day Boat Parade in honor of those that lost their lives on 9/11. How does this tie into boats? It is a story that our Lakes Committee recently learned about and want to share with the community. The short story is on 9/11, people were stranded in Manhattan, with the subways and streets closed they had no where to go. The U.S. Coast Guard put out a call to all vessels in the area to assist. The response was incredible! Boats of all sizes responded, resulting in the largest boatlift in history. If you would like to participate in the Desert Shores Patriot Day Boat Parade, or even just find out more information, there will be a Kick Off meeting on Thursday, June 8th at

6:00 PM in the clubhouse. We will be showing a 12 minute movie about the boatlift and share the plans for the September 10th parade. (More information on page 15)

The majority of the Regatta Drive turf conversion project is complete. Still to come is the area around the main entrance sign monuments at Buffalo and Regatta. The sign monument upgrade is under review with City of Las Vegas Planning, and as soon as we can get the permit, the project can begin and should take approximately one month to complete and then the final touches on the landscaping will be completed.

Phase 2 of the mandatory turf conversion has begun on the Lake Sarah lake side. Since access to the lake side areas is very limited to one end of the lake or the other, this part of the turf conversion is mostly manual labor. The Southern Nevada Water Authority (SNWA) has approved DSCA to receive a rebate for this area. Once Phase 2 is complete, we will apply for a rebate for Phase 3 which will be Soaring Gulls. The Board is looking at adding in North Lake Jacqueline to Phase 3. To qualify for a rebate, each project must be completed within 12 months and only one project can be open at any given time, so those areas would need to be combined as one application with SNWA.

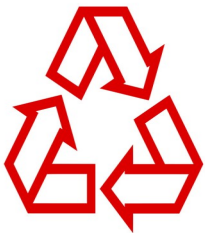
Agendas are available 24 hours prior to the meeting and are posted on the website or in the management office.

Preparing for Summer with Smart Irrigation Controllers

With summer approaching, it's time to adjust your landscape irrigation clock to follow the community's mandatory seasonal watering schedule.

In effect May 1 through Aug. 31, the summer schedule prohibits spray irrigation between 11 a.m. and 7 p.m. Sunday watering is prohibited. However, just because you can water more this summer doesn't mean you need to. Follow these tips to help you maintain a healthy landscape and manage your water bill.



Water in the early morning to minimize the amount of water lost to evaporation and daytime winds.

Water grass on a three- or four-day a week schedule and slowly add additional days as the summer heat increases.



Water your grass no more than 12 minutes total per watering day. It's all your grass needs. Run sprinklers 3 times a day for 4 minutes each cycle, spaced 1 hour apart.



Plants and trees require much less water than grass. Set your drip irrigation to two to three days a week.



The average customer can save up to \$300 annually on their water bills by following the seasonal watering restrictions year-round.

Take advantage of the cash rebate the Southern Nevada Water Authority (SNWA) offers on the purchase of smart irrigation controllers, which use sensors and weather data to automatically adjust irrigation system run times and the amount of water your landscape needs.

The SNWA's rebate offers 50 percent off the purchase price of a new smart controller, or up to \$100, whichever is less. Installing a smart controller can not only help you maintain a healthy landscape through the heat of summer, but it also can help you cut your outdoor water use by as much as 30 percent, which also will save money on your monthly water bill.

The Community Relations Committee "CRC" meets the 1st Monday of each month to review ARC Applications and conduct compliance hearings. In order to have your application on the agenda, you must submit **all completed paperwork** to the DSCA office along with the \$10 application fee by the **Wednesday prior to the CRC meeting by 12:00 PM.**

NOTE: If you reside in **Harbor Cove, Spinnaker Cove, Diamond Bay, La Jolla Classic, Ritz Cove, Desert Shores Racquet Club or Pelican Point**, you are required to obtain approval from your Sub-Association **PRIOR** to submitting your application to Desert Shores. Please keep this in mind when planning your changes to your home. The approval letter is part of the application checklist.

- 1** Seek approval from your Sub-Association if your property is in a gated neighborhood. **Skip this step if you do not live in a gated community.**
- 2** Submit your **complete** ARC application to the DSCA office by the deadline along with a \$10 fee. Applications will then be reviewed by the CRC.
- 3** Notices of Approval/Disapproval will arrive via mail. If your application was approved, you can now begin your project! In case your application was not approved as submitted, please contact the Community Relations Coordinator for the next steps to take.

Should you consider 401(k) loans or withdrawals?

If you're ever faced with a financial crunch, should you consider taking money from your 401(k)?

Ideally, you should avoid it if you can. Your 401(k) is designed for your retirement, which may last decades. So, consider other options, such as withdrawing money from your emergency fund.

But if you feel you have no choice but to tap into your 401(k), think carefully about your next steps.

For plans that allow loans, you can generally borrow up to 50% of the vested amount of your 401(k), up to a maximum of \$50,000 within a 12-month period. You've typically got five years to repay the loan. However, if you leave your job before the loan is paid, you may face tax issues.

For plans that allow withdrawals, you may have to show a demonstrated need, unless you're already 59½. But unlike with loans, some types of 401(k) withdrawals can't be repaid, which could lead to tax issues.

Consult with your tax and financial professionals before taking action on a 401(k) loan or withdrawal. It's a big move, so make sure you know everything that's involved.

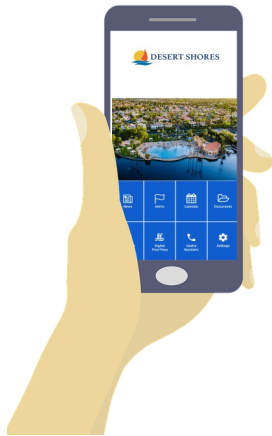
Planning on Selling your home?

Keep these rules in mind when placing your For Sale or Open House Signs:

- ✓ Only one (1) "For Sale/Lease Sign is allowed in each front yard
- ✓ All signs must be professionally prepared and shall not exceed customary dimensions of 36x36
- ✓ Signs shall be displayed only on the lot listed for sale
- ✓ No signs may be placed on Lake Ends
- ✓ 4 "Open House" signs may be used as follows: one (1) may be displayed on the lot, and three (3) additional signs may be used in the common areas except for the lake ends. Additional signs in excess of the four (4) permitted will be removed by DSCA Patrol or Staff.
- ✓ Property Owners are responsible for the actions of their real estate agents with regard to marketing a property in DSCA.

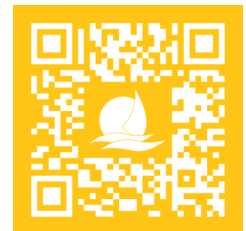

Desert Shores is now Digital! The Digital Membership replaces all physical ID cards. The new system prevents previously issued cards from staying in circulation for access to Desert Shores' private amenities.

Please note that each household is allowed only one Login Account which must be created by the homeowner.

Going digital means saying Good-bye to always carrying a card with you! Downloading the App gives you access to many great features such as:

- ✓ Receiving alerts directly to your phone
- ✓ Checking the Calendar for Events and BOD Meetings
- ✓ Submitting non-emergency requests regarding common areas and facilities
- ✓ Accessing your Digital Membership Card

Landlords & Tenants

All tenants are required to be registered with the DSCA Office if they would like to use the facilities or participate in any Association Activities.

Once the HOA office has all the information required, landlords can now provide the tenant with a reference ID by creating their own Digital Membership! Once approved, they will be able to see their reference ID. (This reference ID number will begin with two letters followed by a series of numbers.)

Alternatively, we will be more than happy to provide your tenant with the reference ID Number.

After providing your tenant with a Reference ID Number, they can now create their own Digital Membership by following the instructions above and signing up as a tenant! Once approved, the tenant may add additional members listed on their lease agreement.

As a landlord, if you would like to assign privileges to your tenant, you will need to submit the following:

- Assignment of Membership Privileges Form
- Lease Agreement
- Property Management Agreement
(if managed by a Property Management Company)

Reminder: Privileges cannot be shared between the legal owner and the tenant(s) of the property.

Once approved by Desert Shores, you will be able to add additional members within your household. Tenants can only add members named on their lease agreement.

Reminder: Only one account can be created per household by either the homeowner or Primary tenant.



Fishing Rules Reminder!



Membership is a Must: All individuals fishing in our lakes must possess a valid DSCA Membership at all times.
No Membership= No Fishing

Catch and Release Policy: We have adopted a Catch and Release Policy to maintain the ecological balance of our lakes. Please release all fish back into the water immediately after catching.

One Pole per Person: Enjoy fishing with no more than one fishing pole per person. Let's keep it fair and enjoyable for everyone. Violators will be asked to leave.

Attentive Fishing: Your fishing line should be attended at all times. It's essential to be present and responsible while fishing.

Throw Lines: Unattended throw lines are strictly prohibited.

Handling Fish: If a fish has swallowed the hook, it's best to release it as is. For fish hooked other than the lip, simply cut the line, and the fish will naturally absorb the hook. Desert Shores stocks the following fish - Bass, Flathead Minnows, Black Crappie, Gambusia, Bluegill, Goldfish, Channel Catfish, Red Ear Sunfish, and White Amur.

Approved Bait: To protect the ecological balance, we allow specific types of bait, such as red worms, night crawlers, mealworms, terrestrial insects (grasshoppers, crickets, etc.), salmon eggs (fish roe), marshmallows, and catfish sink bait. Using freshwater fish as bait is prohibited to prevent the introduction of invasive species.

Keep it Clean: Dispose of trash, rubbish, and debris in designated containers around the lakes. Littering may result in a fine of \$40.00.

Guests and Residents: Non-residents are not permitted to fish, except as guests of residents. Guests must be accompanied by a resident with membership. Each household is allowed up to four (4) guests per day to fish in DSCA lakes. Trespassing laws apply to offenders.

Fishing on the Honor System: Nevada state fishing licenses are not required within Desert Shores. We operate on an honor system basis, but residents must carry their DSCA Membership while fishing.

Fishing in our Lakes: Residents are permitted to fish in all lakes within Desert Shores. It's a wonderful opportunity to enjoy the beauty of our community while engaging in your favorite pastime.


Fishing Hours: Fishing is allowed year-round, starting thirty (30) minutes before dawn and ending thirty (30) minutes past dusk. Make the most of these tranquil hours to cast your lines and reel in some memories.

Considerate Noise Levels: When enjoying your fishing experience, please keep radio and stereo volumes at a moderate level. Let's embrace a peaceful atmosphere for all residents and wildlife.

Lead-Free Sinkers Only: To protect our environment, the use of lead-free sinkers is mandatory. Let's embrace eco-friendly practices for the well-being of our lakes and aquatic life.

Fishing Locations: Unless you own a private dock, all fishing activities are confined to the common lake ends. Members and their guests may fish from their registered boats while maintaining a distance of 20 feet from the shoreline or private docks. 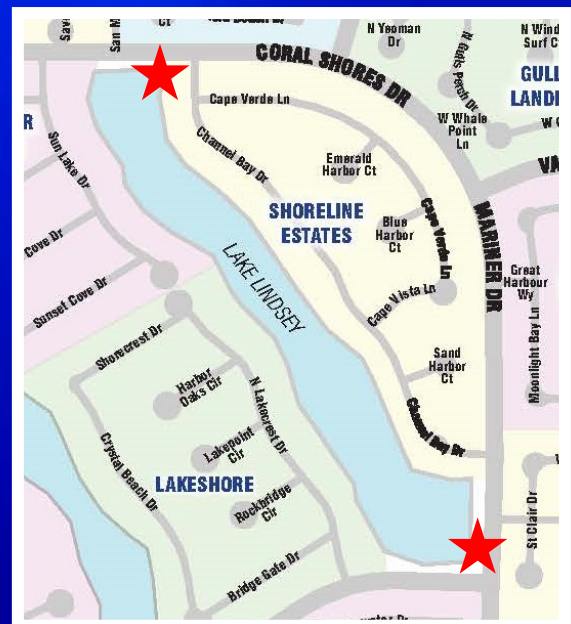

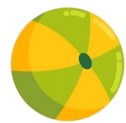

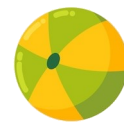
