Our Board of Directors is comprised of dedicated volunteers who are responsible for a wide range of tasks, some of which you may or may not be familiar with. One of their primary functions is to establish and enforce the association's rules. While some residents may have reservations about rules and regulations, it's essential to recognize that the board's primary objective is to safeguard the community's overall well-being. By upholding these rules, the board strives to maintain property values and minimize conflicts. The board's goal is to ensure that these rules benefit the majority, if not all, of our residents. Another significant responsibility is the collection of assessments from homeowners. This financial contribution is vital for our association's stability, as it funds the maintenance of common community elements and contributes to the reserve fund, which covers major repairs. By overseeing the association's finances and collecting assessments, the board ensures our association's financial health.

Community associations operate on the principles of representative government, akin to the foundation of our broader democratic system. It begins with entities like community associations and extends through school boards, city, county, and state governments, all the way to the federal government. We elect individuals who will represent our interests in these positions.

In fulfilling their fiduciary duty, the board often faces challenging and sometimes unpopular decisions, necessitated by our governing documents and Nevada law. **Six of your neighbors have volunteered to run for the three open positions on the board.** We encourage you to take the time to review the ballot information and the candidates' statements. # Fall is a COOL time to save water in Southern Nevada

Fall in Southern Nevada means football, hot pumpkin spice drinks, and a welcome break from the intense heat of summer. The cool days and nights of fall also provide a great opportunity for residents to focus on conserving the community's most precious resource.

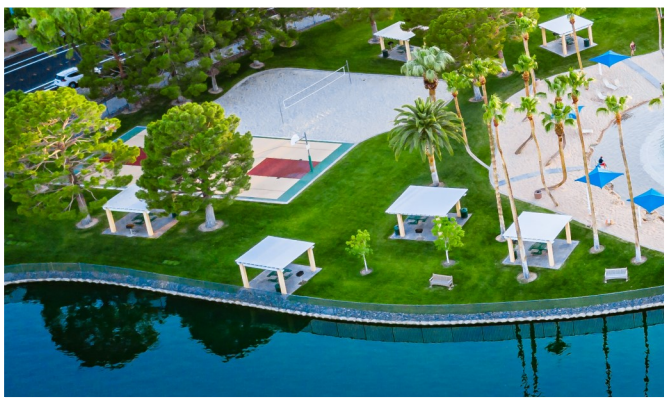
For starters, residents must change their landscape irrigation clock to follow the mandatory seasonal watering restrictions, in effect Sept. 1 through Oct. 31. The mandatory fall restrictions limit landscape irrigation to three assigned watering days per week; Sunday watering is prohibited.

In fall, most landscapes on drip irrigation systems thrive on one to two days of watering per week. Run drip irrigation systems for a recommended 30 to 60 minutes once or twice a week and adjust as needed. Grass should be watered no more than 12 minutes total per watering day, which can be spaced into three 4-minute cycles set one hour apart to avoid run-off. For more watering tips and to find your assigned watering days, visit [snwa.com](http://snwa.com).

Meanwhile, fall also is an ideal time to upgrade your grass landscape to water-efficient, drip-irrigated plants and trees through the Southern Nevada Water Authority's (SNWA) Water Smart Landscape Rebate program (WSL). Whether you do the work yourself or hire a water-smart contractor, you can earn a cash incentive of up to \$3 per square foot of grass you replace with desert-adapted landscaping and \$100 for every new tree planted in your water-efficient yard (restrictions apply).

To help residents choose which new trees best complement their landscape, the SNWA recommends such species as Weeping Acacia, Foothill Palo Verde, and Western Honey Mesquite. One of the requirements of the program is having enough trees to cover at least 50 percent of living plant cover at maturity. A comprehensive list of recommended trees is available at [snwa.com](http://snwa.com).

## Remembering Heroes: A Patriot Day Tribute!

Patriot Day is observed Annually on September 11th as a solemn day of remembrance, dedicated to honoring and paying tribute to the victims and heroes of the tragic terrorist attacks that occurred on September 11, 2001.

"Boatlift", a 12-minute documentary, captured stories of courageous captains of ferries and tugboats who united in Lower Manhattan to execute the largest water evacuation in history. As road, tunnel and railway closures isolated Lower Manhattan, following the World Trade Center attacks, over half a million individuals found themselves stranded. The extraordinary "Boatlift" operation brought together over 150 American Maritime Vessels, including passenger ferries, tugboats, merchant ships, private vessels, as well as the New York Fire Department and Police Department Boats. More than 800 American Mariners valiantly participated in the "Boatlift" of 9/11.

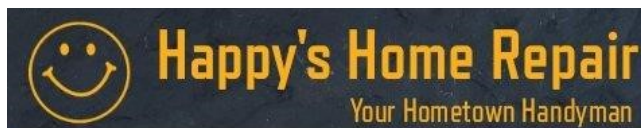

## LOCAL HOUSING MARKET UPDATE

New home listings in the valley dropped nearly 52 percent in July 2023 from a year earlier, according to new data from Las Vegas Realtors. This historically low inventory of homes for sale, combined with higher mortgage rates and other factors, has created a unique housing market in Las Vegas. Las Vegas Realtors reported 3,524 single-family homes listed for sale in the valley without any sort of offer in July, a 4.2 percent drop from June but a 51.9 percent drop from the same time last year. However, Las Vegas was the only metropolitan area in the United States that saw a bump in pending home sales over the past month. Additionally, a recent Redfin report shows Las Vegas had the country's largest drop in new listings over the past four weeks, at 43.4 percent. The metropolitan area also had the fourth-largest decline in home sale prices over that period (3.5 percent). The median list price for a single-family home in the valley in July dropped 0.1 percent from June to \$499,173, which is essentially the same median price for a home this time last year. Experts agree the local inventory is at a historical low for several reasons. One being the Federal Housing

Administration's forbearance program instituted during the COVID-19 pandemic, which allowed some homeowners to pause or reduce mortgage payments. Thousands of forbearances have allowed homeowners to take their home off the market or not put their home on the market. By doing a forbearance they don't have to make a mortgage payment for 6-18 months. With many people having low interest rates between 2 and 3.5 percent, it doesn't make sense to sell their home and move up or move down when their new rate is going to be around 7 percent. Many sellers are buying another home, keeping the one they live in and renting that out. In the past they would almost always sell and buy. Now it's rent and buy. Homeowners are using that extra cash flow to subsidize the payments on the new home. Investors coming into the market have caused an imbalance as well. This is hurting average buyers. Hedge funds own tens of thousands of starter homes in Las Vegas which most likely will not be coming off the market, making inventory in homes under \$500,000 scarce.
