UPDATED MASK POLICY

Clubhouse Reservations Updated Fees & Schedule

The Desert Shores Clubhouse, located next to the Lagoon Beach Park, has long been a highly sought after location to host Resident's cherished celebrations and events.

With its all encompassing views of the Lake and Lagoon Beach, tables and chairs to seat up to 100 guests, commercially equipped prep kitchen, and access to Community Lagoon Beach, Park and Boats, you would be hard pressed to find a venue for your event that outshines the DSCA Clubhouse.

Due to increased costs in labor and services, as of March 1st, the following changes have been made to the Clubhouse Reservation Guidelines:

- Partial Day (4 Hour or 6 Hour) Reservations are no longer available.
- Reservation fee is now \$350 for the full day. Full Day Reservation times are 10:00 AM to 11:00 PM (Sun.-Thurs.) or 12:00 AM (Fri. & Sat.)

NOTE: If you reside in Harbor Cove, Spinnaker Cove, Diamond Bay, La Jolla Classic, Ritz Cove, Desert Shores Racquet Club or Pelican Point, you are required to obtain approval from your Sub-Association PRIOR to submitting your application to Desert Shores. Please keep this in mind when planning your changes to your home. The approval letter is part of the application checklist.





THE REAL (ESTATE) FACTS

If you haven't bought a home in a while and are thinking of doing so keep in mind according to lender surveys the average down payment is between 8 percent and 10 percent, but borrowers can put as little as 3 percent down on a home. There are many options and borrowers can choose their comfort level whether that's 3 percent, 5 percent, 10 percent, or 20 percent down.

Given a choice, some buyers may choose to put 20 percent down to have a lower payment. As rates remain low many others want to take advantage of getting maximum financing to be able to put their assets to work elsewhere. Some buyers may want to hold on to those additional funds in case they need to make repairs or renovations to the property. They may also want to make sure they have enough funds available in case an emergency comes up.

An alternative to 20 percent down is private mortgage insurance (PMI). Lenders are concerned that a borrower does not have enough skin in the game when making the lesser down payment, so they will incorporate mortgage insurance which protects the lender in case of default. Mortgage insurance varies based on several factors, which are indicative of the ability to repay, including your credit score, the amount of financing you are taking, and the loan to value.

You could also potentially take out two loans to cover the total needed. One for 80 percent of the purchase price and then a second for the remainder." Lenders call this a "piggyback" loan, and it avoids the PMI requirement.

Keep in mind that not all mortgages are created equal, and

the likelihood of finding one that suits your needs are extremely high. Lenders look at the total picture to determine a buyer's ability to make payments. The greatest factors in determining loan eligibility are credit histories, income sources, and debt-to-income ratios.

Fortunately, there are several programs for buyers to choose from. FHA loans that often lar, and they often require only 3.5 percent down. VA loans are also available to those who have served in one of the military branches. There are also conventional loan options that don't require 20 percent down. Lastly there are programs that provide down payment assistance. And local lenders may know of other opportunities.

With rates as low as they are, a great way to have both an affordable payment and peace of mind is by adding \$25 to \$50 a month to the payment while keeping \$5,000 to \$10,000 in the bank for emergencies.



CRIME PREVENTION TIPS

Crime Triangle

Three things are needed for a crime to take place:



Opportunity to commit the crime.

What side of the equation can we control? **Opportunity!** Here are some tips to help remove opportunity from the equation!

MAIL THEFT & PORCH PIRATES

- Report all mail theft, open/damaged mail boxes to the local USPS office.
- Schedule deliveries when you will be home.
- Take advantage of secure locker locations for deliveries.
- Have packages delivered to your work address instead of your home.
- Get your mail from your box, everyday and as soon as possible. Criminals are familiar with delivery schedules.
- Going out of town for an extended period?
 Request USPS to hold mail at post office until your return.
- Important outgoing mail? Opt to drop off at the Post Office directly vs. the outgoing mail slot.



ALARMS & SECURITY TIPS

- Make sure to use alarms and sensors on ALL entry points of your home: windows, sliding glass doors, etc.
- Invest in Security Laminate for glass doors and windows. Helps prevent glass from shattering in attempted break-ins.

GUN SAFETY & PREPAREDNESS

- NEVER leave firearms in the car!
- Remember... any weapon you use can also be used against you.
- Be Proficient! Make sure you are trained and knowledgeable about the weapon you own and carry.
- Take <u>your</u> firearm, regularly, for shooting practice and keep well maintained.
- Record the serial number of your gun. In the event of theft, reporting your serial number will aid in the recovery of your stolen weapon.

BURGLARY PREVENTION TIPS

- Don't leave anything valuable or the appearance of valuables (charger cords/cases) in your car and in view.
- LOCK your Doors! Car doors, front, back doors.... Everything!
- Close your Garage DOOR!
- Build relationships with your Neighbors.
- Get a dog No matter the size, a home with a barking dog is not a criminal's ideal target!



- Make your home look occupied Lights on or motion sensor activated, trim shrubs/foliage, add shades/window coverings.
- Record serial numbers of all valuable items. Make sure to inventory your items, including pictures.
- Don't allow piggy backing at gated entries. You may feel awkward but you lessen the efficacy of gate by allowing entry.
- Protect Gate Codes at all times! Alert your Sub-Association, immediately, if you see codes posted at gate or know that a code has been compromised.







MANDATORY SPRING WATERING RESTRICTIONS IN EFFECT

As the chill of winter gives way to the warmer days of spring, you may be tempted to pump up your irrigation watering. The Southern Nevada Water Authority (SNWA) reminds residents that mandatory spring watering restrictions are in effect now until April 30.

The spring restrictions allows spray irrigation up to **three assigned days per week**. Drip irrigation can operate two to three times per week (landscape irrigation is prohibited on Sunday year-round). To find your assigned watering days, and for tips on how to water or maintain your landscape, visit **snwa.com**.

You can save water—and money on your monthly bills—by slowly "ramping up" your irrigation schedule from one to three days as it gets warmer and as weather patterns permit.

Watering outside of your three assigned days or allowing water to spray or flow off your property could incur fines ranging

from \$40 to \$80 for the first violation and up to \$1,280 for repeated violations. Along with following the seasonal restrictions, periodically inspecting your landscape irrigation system for broken or misaligned sprinklers can help you avoid potentially costly water-waste fines.

Conserving water and reporting and preventing water-waste are critical as the water shortage declaration on the Colorado River limits the amount of water Southern Nevada can withdraw from Lake Mead—the source of 90 percent of our supply—by 7 billion gallons this year.

Another way you can help conserve the community's most vital natural resource is by upgrading your thirsty grass with beautiful water-efficient plants, trees, and shrubs through the SNWA Water Smart Landscapes Rebate Program (WSL).

WSL offers a cash incentive of up to \$3 for each square foot of turf converted to drip-irrigated landscaping. (Some restrictions apply.) Find out more and enroll today at snwa.com.

LOCAL HOUSING MARKET UPDATE

A recent report by the Las Vegas REALTORS® (LVR) shows the local housing market continuing its run of record home prices and an increasingly tight housing supply. LVR reported that the median price of existing single-family homes sold in Southern Nevada through its Multiple Listing Service (MLS) during February 2022 was \$450,000. That tops the previous record set in January. The median home price is up 26.8% from \$355,000 one year ago.

The median price of local condominiums and town-homes sold in February 2022 increased to \$260,000. That also breaks the all-time record set the previous month and is up 31.6% from \$197,500 in February of 2021.

LVR President Brandon Roberts said "local home prices have more than tripled over the past decade. Prices have been climbing steadily since hitting their post-recession bottom in January of 2012, when the existing single family home price in Southern Nevada was \$118,000."

"Local home prices can't keep going up this fast forever, "Roberts stated. "The increases we've been seeing in the last year or so are just not sustainable. It remains to be seen how much higher these prices can go and when we might start to see the market stabilize, as many national experts have been predicting."

Similar to the past few months, February's sales pace equates to less than a one-month supply of properties available for sale.

During February, LVR reported that 30% of all local property sales were purchased with cash. That's up from 26.0% one year ago. While that percentage increased over the past year, it's still below the March 2013 cash buyer peak of 59.5%.

The number of so-called distressed sales remain near historically low levels at just 0.4% of all existing local property sales.

These LVR statistics include activity through the end of February 2022. LVR distributes statistics each month based on data collected through its MLS, which does not account for all newly constructed homes sold by local builders or homes for sale by owners.

- Designing your own landscape can be overwhelming. Use these tips to ensure the design process of your landscape goes smoothly:

- Decide in advance how much you can afford to spend.
- Create a timeline to make the most of each season during the planting and installation process.
- Know your zones (mini-oasis, transition, arid).
- Take photos of eye-catching plants or plant groupings you may want to use in your landscape.
- Consider blooming seasons when planning your landscape.
- Create a focal point for each part of your property. Use lines throughout your landscape to define the space and direct the eye to those focal points.
- Use repeating shapes, colors and textures to pull your landscape design together.
- Account for plant growth and future water needs by planning your irrigation system for several years in advance.
- Buy smaller plants to save money.
- Place trees first as an anchor and work your way outward. Be sure to allow enough room for root growth.
